# **NEW BUSINESS:**

First Reading of Ordinance 4-2025 Town of Darlington 2026 budget. After some discussion the final reading and adoption will be held on September 18, 2025.

Clerk Cash informed the council of a customer who had by passed the electric for 5 months. Marshall Crull and Attorney Nichols will be taking care of the charges for the violation.

Clerk Cash presented an offer for the empty lot that was presented by Matt Walters. After review the council decided to counter offer and extend the time for the purchasers to get confirmation from the county on a possible rebuild. A motion to counter offer was made by Jennifer Flaugher, seconded by Jeremy Weliever. Motion Approved (5-0)

There was much discussion about the truck route and the progress being made for the signage from INDOT. Councilmen Jeremey Weliever informed the council he would be meeting with INDOT and the County to discuss a solution for the signs. Mr. Weliver will update the council at the next meeting.

The council took that under advisement and asked Attorney Nichols to look into a possible agreement and will decide at the October meeting.

MVH Report- Mr. Mullen updated the council on the truck signs. Mr. Mullen presented the council with a quote from Price Excavating for the project on School and Main for 700 on the stormwater issue. Mr. Mullen will be getting another quote to bring to the next meeting.
