### **PUBLIC COMMENT:**

#### **NEW BUSINESS:**

Ordinance 1-2025 Truck Route was presented to the council for discussion and review. After much discussion the council asked that the town attorney go forward with the ordinance and the first reading will be at the June meeting.

Clerk Cash presented some photos of two potential unsafe building in the downtown area. After reviewing the concerns, the council directed the clerk to have the attorney send letters to the property owners to have them looked at and then report back to the council at the June meeting.

## **OLD BUSINESS:**

Clerk Cash reported on the effects of HB1 and the steps needed to meet the budget requirements for 2026.

Clerk Cash and Councilmen Jeremy Weliever gave an update on the Community Center. Quotes are coming in and will be presented when all are received.

Clerk Cash reported the tornado siren is up and running and doing the weekly test.

A motion to allow Mike Smith to mow abandoned house before they get out of control for a fee of \$100.00 and not to exceed more than twice a month, and pay the invoice out of CCI was made by Jennifer Flaugher, seconded by Jeremy Weliever, with Vice President Teresa Sutherlin abstaining. Wastewater Report —Clerk Cash presented a revenue report on the wastewater fund. The council discussed two options selling the wastewater company to Aqua who currently owns the water utility of raise the flat fee by 5%. The flat fee raise will be minimal to the residents and would help offset the rising cost of the operation of the plant. With the current cost of replacement, material, sludge removal and several cost, Jeremy Weliever made a motion to increase the flat fee by 5% once a public hearing is held and two required council meeting which will be held in June and July with the increase going into effect August, 2025, seconded by Vice President Teresa Sutherlin. Motion Approved (4-0)

Electric Report – Superintendent Brian Mullen updated on the council progress in the electrical department.

MVH Report- Mr. Mullen reported updated the council on the patch work completed on the roads.

Darlington Police Department – Marshall Kevin Crull sent the April 2025 activity logs and the May 2025 police schedule in an email. Mr. Crull will be looking into cameras for the Town Hall.
